## **ERAYADA AAD RABTO INAAD GARATO**



### **LAMBARKA A :**

Saraakiisha laanta socdaalka waxay ku siin doonaan lambar oo ay saraakiisha laanta socdaalka iyo xaakimka laanta socdaalka ay u isticmaali doonaan inay kugu aqoonsadaan. Lambarkan waxaad ka heli kartaa dukumintiyadaada laanta socdaalka. Waxay leedahay sagaal tiro lambar oo ka bilaabaneysa xarafka "A"

### **MAGANGELYADA :**

Magangelyadu waa badbaado la siiyo dad aan ku amaan qabin dalkooda sababo la xiriira jinsi, xubin ahaanshaha koox bulsho gaar ah, fikir siyaasadeed, jinsiyad ama diin. Haddi magangelyo lagu siiyo, waxaad si sharci ah ku joogi kartaa dalka Mareykanka.

### **QAREENKA (SHARCI-YAQAAANKA) :**

Qofka adiga ku matalaya xaakinka hortiisa iyo saraakiisha dawlada. Qareenkaaga wuxuu kuu sheegi doonaa haddii aad u qalanto faa'lido kasta oo hoos imaaneysa shuruucda laanta socdaalka ee Maraykanka wuxuuna kaaga jawaabi doonaa su'aalahaaga ku saabsan sharciga iyo xuquuqdaada aad dalka Mareykanka ku leedahay. Qareenkaaga adiga ayuu kuu shaqeynaya wuxuna kaa caawinaya inta aad maxkamada joogto iyo saraakiisha laanta socdaalka. Macluumaadka aad la qeybsato shariyaqaankaaga waa sir sharci-yaqaaankuna lama qeybsan karo dad kale ilaa aad adiga ka ogolaato macluumadkaas.

### **U DOODISTA BADBAADINTA CARRUURTA :**

Qofka loo qoondeyn karo inuu caawiyo dadka oo idil ee kaala shaqeynaya inaad fahanto waxa ay danahaagu yihiin. U dooduhu ma aha qareenkaaga (shariyaqaan). Macluumaadka aad u sheegeyso udoodahaaga wuxuu noqon karaa mi sir ah.

### **SIRTA :**

Sir macnaheedu waa qarsoodi ama qaas. Qareenk waa inuu xifdiyaa macluumaadka badankooda ee sirta ah ilaa aad adiga ka ogolaato inuu la qeybsado dadka kale mooyaane.

#### **WAAXDA AMNIGA GUDAHAD (DHS) :**

Saraakiisha laanta socdaalka iyo qareenada dawlada ee ku sugaran maxkamada waxay u shaqeeyaa DHS. DHS waxay leedahay laamo kala duwan. Laanta wakiilka ka ah saraakiisha laanta socdaalka iyo dawladaba ee maxkamada ku sugaran waa laanta socdaalka & dhaqangelinta meelaha cashuurta la isaga qaado ee alaabta dalka soo galeysa ama ka bexeysa. (ICE).

#### **XAFIISKA DIB U DEJINTA QAXOOTIGA (ORR) :**

Qeyb ka mid ah dawlada federaaliga ayaa masuul kaa ah inta aad xirantahay ama daryeel korinta federaaliga waxayna go'aan ka gaareysaa in laguugu sii daayo xubnahaaga qoyska ee Mareykanka jooga. Qeybtan dawlada ka mid ah waa ay ka baxsantahay DHS/ICE iyo maxkamada laanta socdaalka.

#### **MASAAFURIN (TARXIIL) :**

Markuu go'aamo xaakimka laanta socdaalka inaad wadankaaga ku laabanayo. xaakimka waxa uu gudagalayaa amarkiisa ee adiga ka dhanka ah ee tarxiilida. Markii lagu masaafuriyo, waxaa laguugu celinayaa wadankaaga mana laguu ogolaanayo in laguu fasaxo inaad ku laabato dalka Mareykanka mudo tobant sano ah, ilaa aad ka hesho saamaxaad gaar ah.

#### **XIRMADA DIB U MIDEYNTA QOYS (FRP) :**

Dukumintiga loo diro qaraabadaada ee Mareykanka joogta haddii ay doonayaan inaad ayag la joogto inta uu xaakimka go'aan ka gaarin kiiskaaga.

Qaraabadaadu waa inay awoodi karaan inay tusiyaan inaad adiga kaa faalaqaadi karaan inta aad joogto dalka Mareykanka.

#### **QOYNSKA ILMAGA AYSAN DHALIN KORIYA:**

Qoyska ilmaha aysan dhalin koriya waa qoys ay dawlada Mareykanka ay ansixisay inay daryeelaan carruurta muhaajiriinta ee aan haysan wax qaraabo ah oo ku xanaaneeyaa dalka Mareykanka. Dawladu waxay go'aamisaa hadduu ilmuhi lagu sii deyn karo qoyska ilmaha dhulin koriya. Intii aad la nooshahay qoyska ilmaha dhulin koriya, kiiskaaga laanta socdaalka wuu soconaya. Ma awoodi doontid inaad si joogto ah ula joogto qoyska ilmaha dhulin koriya.

#### **MAXKAMADA LAANTA SOCDAALKA:**

Kiisaska laanta socdaalka yaala waxaa go'aan ka gaaraya maxkamada laanta socdaalka. Magaaloooyin badan oo kala duwan oo ku yaala dalka Mareykanka ayaa waxay leeyihiin maxkamadaha laanta socdaalka. Maxkamadaha laanta socdaalka qeyb kama ah DHS/ICE.

#### **XAAKIMKA LAANTA SOCDAALKA :**

Kani waa qofka ka go'aan gaaraya kiiskaaga laanta socdaalka. Xaakimku waxa uu dhegeysanayaa waxa adiga iyo qareenkaaga aad dheheysaan ama aad soo bandhigtaan waxaa kale oo uu dhegeysanayaa waxa qareenka DHS/ICE uu ka odhanayo sababta aadan ama aad u joogi karto dalka Mareykanka.

#### **DEGENAANSHAHA JOOGTADA EE SHARCIGA AH.**

Degenanshaha joogtada ee sharciga ah waxaa la siiyaa qof ka yimid meel ka baxsan dalka Mareykanka oo fasax loo siiyey inuu si joogto ah ugu nagaado.

**CARRUURTA:**

Waa qof ka yar 18 sano jir.

**OGEYSIISKA MAXKAMAD SOO TAAGISTA:**

Ogeysiiska maxkamad soo hor-istaagistu waa dukuminti ka soo baxay dawlada Mareykanka oo sharaxaya sababta ay dawlada ay u rabto inay ku masaafuriso.

**HEERKA DHALINYARADA****MUHAAJIRIINTA QAASKA AH (SIJS) :**

SIJS waa nooc badbaadinta carruurta ee laanta socdaalka ee lagu xadgudbay, la deyriyey, ama ay dayaceen waalidiintooda ama ilaaliyahooda. Carruurta waalidkooda dhintay waxay sidoo kale xaq u leeyihiiin badbaadadan.

**QUMANAANTA QIIMEYNTA:**

Markay qaraabodu warsadaan ORR, hay'adaha dawlada ee haya carruurta, waxayna carruurtaasi ku si deysaa xanaanadooda, ORR waxay mararka qaarkooda guriga u dirtaa qof kamid qaraabada si uu u hubiyo in gurigu u tahay meel badbaadooo qaraabaduna awoodaan inay xanaaneeyaan carruurta.

**DAL-KU-GALKA U:**

Nooca badbaadinta laanta socdaalka waxay u ogolaaneysaa in shaqsiga dhibanaha ah ay dembi ku tahay inuu si sharci doro ah ku joogo dalka si sharci doro ah ku joogo dalka Mareykanka. Si aad ugu qalanto, bukaanku waa inuu u soo sheegaa denbiga booliska uuna kala shaqeeyaa denbi baarista ama dacwada denbiga.

**DAL-KU-GALKA T:**

Nooca badbaadinta laanta socdaalka ee dhibaanada sida suuqmadowga dad gudbinta. Dhibanaha suuqmadowga dadgudbinta waa qof sameeyo inuu dad keeno dalka Mareykanka lagu qasbo inay ku shaqeeyaan ama fal lid ku ah dalka Mareykanka balse ma aha muwaadin Mareykan ah. Dukumintiga muujinaya in fasaxan la siiyey ayaa inta badan waxaa loogu yeeraa kaadhka cagaaran rabitaankooda inta ay joogaan dalka Mareykanka.

**AAN RASMI AHEYN:**

Qofka aan rasmiga aheyn waa qof jooga dalka Mareykanka isagoon fasax ka heysan dawlada Mareykanka.

**TEGIS IKHTIYAARI AH:**

Xaakimku waxa uu kuu ogolaan karaa inaad dalka Mareykanka isaga tagto ikhtiyaarigaaga, iyadoon amar la soo saarin oo masaafuris. Haddaad u tagto si ikhtiyaari ah, waxad mustaqbalka awodi kartaa inaad si sharci ah ugu soo laabato dalka Mareykanka, waa haddii aad u qalanto dal-ku-galka.

**OGOLAANSHO SHAQADA:**

Saraakiisha laanta socdaalka waxay mararka qaarkood u ogolaadaan muhaajiriinta intey joogaan dalka Mareykanka. Fasaxan waxaa loogu yeeraa ogolaansho shaqo. Markii ay dawlada Mareykanka u ogolaato muhaajiriitna inay shaqeystaan, dawlada waxay qofka siinaysaa kaadh, loogu yeedho Dukumintiga Shaqo u ogolaanshaha (EAD).



## **MAXAAN ANIGU UGU SUGANAHAY XARUNTAN?**

Meesha aad hadda ku sugan tahay waa xarunta lagu xiro dadka da'dooda ka hooseysa ee laanta socdaalka. Halkan baad ku suagan tahay waayo Dawlada Mareykanka waxay aaminsan tahay inaadan fasax u heysan inaad joogto dalka Mareykanka. Inaad joogto dalka Mareykanka, xaakimka laanta socdaalka ama saraakiisha laanta socdaalka waa inay go'aan ka gaaraan inaad haysato sabab sharci ah oo aad ku joogto. Qareenkaaga wuxuu kaa caawin karaa inaad la hadasho xaakimka ama saraakiisha. Waxay qaadan kartaa billooyin badan kahor intaadan helin go'aanka kasoo xaakimka.

## **MIYAAN JOOGI KARAA DALKA MAREYKANKA?**

Xaakimka laanta socdaalka ama saraakisha laanta socdaalka keliya ayaa go'aan ka gaari kara haddii aad si sharci ah u joogi karto dalka Mareykanka, ama haddii aad dalkaaga ku laabanayso. Fadlan dulqaado intey hannaanka laanta socdaalka ay qaadanayso oo mudo dheer. Xitaa haddii aad horey u ogeyd waxa aad rabtay inaad ogaato, weli waad sii xirnaan kartaa billooyin badan. Mudada dhabta ah ay qaadanayso waxay hadba ku xirnaan doontaa waxyaabo badan oo soo baxa, oo ay isugu jiraan hadba sidey dawlada u wado howlaha waraaqahaaga, iyo nooca kiista aad haysato.



# **MAXAY KALA YIHIIN NOOCYADA XARUMAHA LA ISKU XIRO?**



## **• XARUMAHA GABAADKA:**

Meelahan ah xarumaha la isku xiro waxay leeyihii heerka amniga oo hooseeya, iyo heerka xoriyada ay sarreeya. Carruurta ku nool gabaadka xarunta waxay si joogto ah u booqanayaan jiimka, xorna u yihiin inay daawadaan teleefishinka, cayaaraan cayaaraha fiidiyowga, oo ayna akhristaan. NIJC waxay caadi ahaan si isbuucle ah booqasho ugu sameeyaan Xarunta Caalamiga ee Carruurta (ICC) Xarunta Caalamiga ee Caruurta Beverly (ICCB) waxaad kaloo ka heli kartaa teleefanka maalmaha Arbacada inta u dhexeysa 2-4 galabnimo.

## **• XARUMAHA BADBAADADA-SHAQAALAH:**

Xarumahan la isku xiro heerkooda amniga waa ay ka sareeyaan marka loo eego xarumaha gabaadka. Carruurta ku nool xarunta badbaadada-shaqaalaha waxay helayaan mudnaan gaar ah ay ku aadaan jiimka ama ay ku cayaaraan fiidiyowga cayaaraha, inkastoo ay weli haystaan xuquuq ay ku helayaan madadaalo maalintiiba. Inkastoo carruurta ku sugar xarumaha badbaadada-shaqaalaha mararka qaarkood lagu xiro denbiyo yaryar, inta badan waxay qabaan dhibaatooyin habdhaqan ah halkii ay ka ahaan laheyd arimaha denbiga. Xarunta Dhalinyarada Caalamiga (IYC) waa tusaalaha xarunta badbaadaba-shaqaalaha. NIJC waxay caadi ahaan si isbuucle ah booqasho ugu sameeyaan IYC, waxaadna heli kartaa teleefanka.

## **• XARUMAHA BADBAADADA-SHAQALAH EE DABIIBKA:**

Xarumahan la isku xiro waxay leeyihii heerar sarreeya oo kormeiris ah iyadoo la siinayo shaqaale lagu soo kordhiyey shaqaale lala bardardhigay caruurta. Xaruntan waxaa laga heli karraa carruur baahi gaar ah u qabta xaadal caafmaad gaar ah ama mid cilmi-nafsi ah. Dhalinyarada Muhaajiriinta ee Daryeelka ku Xeeldheer (SCIY) waxay tusaale u yihiin xarunta la isku xiro ee badbaadada-shaqaalaha dabiibida. NIJC waxay caadi ahaan booqasho ku sameysaa SCIY isbuuc dhaaf, waxaadna ka heli kartaa teleefanka.

## **• XARUMAHA BADBAADADA:**

Xarumahan la isku xiro waxay leeyihii amni aad u sarreeya, iyo xoriyad heerkeedu yar tahay. Intabaden albaabada idilkood oo kuyaala xarunta badbaada waa ay wada xiran yihiin. Badankooda carruurta ku sugar xarumaha amniga waxay ku lug lahaayeen nidaamka cadaalada dhalinyarada ama nidaam denbiyedka. Chicago agagaaraheeda ma laha xarumo badbaado.

## **MA U GUURI KARAA XARUN KA DUWAN?**

Sida qaalibka ah, shaqaalaha ku sugar meelaha la isku xiro si wadajir ah ayaa waxay uga wada shaqeeyaan ORR inay carruurta xarun ka raraan una raraan meel kale. Inta badan tani waxay sabab u tahay habdhaqanka carruurta. Habdhaqan wanaaga waxay kaa caawin kartaa in laguu geeyo xarun la isku xiro oo ilaalo hooseeyo (oo xoriyad badan leh). Si kale, habdhaqan xumida waxay kaa caawin kartaa hoos lagu geeyo xarun la isku xiro oo ilaalo sarreeyo (oo ka xoriyad yar).

## **MAXAY YIHIIN XUQUUQAH AAN KU LEEYAHAY XARUNTA LA ISKU XIRO?**

INKASTOO AAD XIRAN TAHAY, WELI XAQ BAAD LEEDAHAY:

### **WAA MAXAY XUQUUQDEYDA AAN KU LEEYAHAY DARYEELKA AASAASIGA AH?**

- Waxaad xaq u leedahay baahidaada guri habboon (cunto, gogol-jiif, dhar nadiif ah, inaad hesho saabuun, daawada ilkaha, iyo badeecoojin kale).
- Waxaad xaq u leedahay inaad aragto dhakhtar haddaad u baahato daryeel caafimaad.  
\*\*Haddaad xanuun dareemeyso, durbadiiba u sheeg kiiskaaga-qofka-kushaqa-leh.\*\*
- Waxad xaq u leedahay daryeel ilkaha oo degdeg ah.
- Waxaad fursad u heli doontaa inaad la hadasho qoyskaaga kafiilada iman kara isbuuc kasta. Waxaad wici kartaa qoyskaaga ku sugar dalka Mareykanka ama dibada.
- Waxaad xaq u leedahay madadaalo iyo howl-qabad jirka la xiriira, oo isugu jira waqtii banaanka aad u baxdo markay cimilada ay kuu ogolaato.
- Waxaad xaq u leedahay inaad hesho gelida adeegyada diimeed ee dooqaaga ah mar waliba oo suurogal. ah



### **BAL KA WARAN WICITAANKA QAREENKEYGA AMA DHAKHTARKEYGA?**

- Waxaad xaq u leedahayinaad wacdo qareenkaaga ama dhakhtarkaaga.
- Waxaad xaq u leedahay inad si gaar ah ula hadasho qareenkaaga ama dhakhtarkaaga. Qareenada NIJC waxay leeyihiin saacado ay xafiiska joogaan marka aad weceyso. Warso qofka-kiiskaaga-ku-shaqa-leh haddaad u baahato inaad la hadasho qareenkaaga.

### **MAXAA DHACAYA HADDAAN GAARO 18 ANIGOO KU NOOL XARUNTA?**

- Kadib markaad 18 gaarto, saraakiisha DHS/ICE waxay kaa rarayaan xarunta lagu xiro currurta waxayna ku geynayaan xarunta la isku xiro ee dadka waaweyn. Adiga iyo qareenkaaga waa inaad isku daydaan inaad sameysaan diyaargarowgaaga aad uga tegeyso xarunta kahor intaadan gaarinta maalinta sannadguurada dhalashadaada 18aad.

## **MA LA IIGA SII DEYN KARAA XARIGA SI AAN ULA JOOGO XUBIN QOYSKEYGA KA MID AH?**

Carruur badan ayaa laga sii daayaa xariga si ay ula noolaadaan qoysaskooda. Intaad xariga ku jirto, Xafiiska Dib-u-dejinta Qaxootiga (ORR) wuxuu ku shaqo leeyahay daryeelistaaada. ORR waa inay go'aan ka gaaraan hadey amaan kuu tahay in laguugu sii daayo qoyskaaga. Waxay u baahan yihii inay hubiyaan qofka aad rabto inaad la noolaato inuu yahay qof xilkas oo amaan ah, oo aan halis galeyn inta aad la nooshahay xubnahaaga qoyska. Haddaadan dalka Mareykanka ku laheyn qoys, waxaad awoodi kartaa inaad la noolaato saaxiibka qoyska.

## **XUBNAHA QOYSKEYGA WAA KUWO AAN RASMI AHEYN. WELI MALA II SII DEYN KARAA?**

Waxaa laguugu sii deyn KARAA xubnaha qoyska ee aan heysan fasax ay ku joogaan dalka Mareykanka (isaga ama iyadu ma laha dukuminti/rasmi ma'aha). Si kastaba ha'ahaatee, xubnaha qoyskaaga waa in farihiisa/heeda ay dawlada ka baartaa, waxay halis ku noqon kartaa xubnaha qoyskaaga: 1 hadii xubnaha qoyskaaga horey loo masaafuriyey ama ay dhib ka jiraana xaga dawlada, iyo/ama 2 haddii xubnaha qoyskaaga hadey u jarun tahay waraaq lagu soo xirayo, amaba uu galay denbiyo halis ah. Waxay kaloo halis ka jirtaa dhanka safarka markuu qof aan dukuminti laheyn, sida xubin qoyskaaga ka mid ah, lagu xiro xarunta la isku xiro ee rabay inuu guriga ku geeyo. Kala hadalu qofka-ku-shaqa-leh-kiiskaaga haddaад wax su'aal qabto.



## BAL KA WARAN HADDAANBA LAHEYNA QOYS? WELI MA LA IIGA SII DEYN KARAA XARIGA?

Waxaad awoodi kartaa in lagu sii daayo iyadoo ay ku xiran tahay da'daada, halka laguugu xiray, iyo haddaad u qalanto dal-ku-gal. Carruurta qaar ee u qalanta sixid sharci ah ayaa waxay xaq u leeyihiiin in xariga laga sii daayo oo loo gudbiyo xanaanada ilmaha aan qofka dhalin koriya. Xanaanada qofka ilmaha uusan dhalin koriya waa markii aad awoodo inaad la noolaato qoyska ee ay dawladu ay horey u ansixisay. Wuxaan kiiskaaga laanta socdaalka ku dhameyn kartaa inta aad la nooshahay qoyska ku soo korsaday. Magaaloojin badan ayaa waxaa ka jira qoysas ilmo aysan dhalin koriya ee dalka Mareykanka. Qareenkaaga waxa uu codsan karaa in laguu geeyo qoys qeyb Mareykanka ah balse go'aanka waxaa iskaleh halka lagu geynayo. Haddii laguugu sii daayo xanaanada qof ilmo uusan dhalin koriya, waxaa laguugu xiriirinayaqareen cusub oo si iskuduubni ah ula shaqeeya gurigaaga cusub.
